# PROJECT JUSTIFICATION

#### INNOVATION IS A SOCIAL PROCESS

 THE EFFECTIVENESS OF R&I STRATEGIES HEAVILY RELIES ON HUMAN CAPITAL, ESPECIALLY THE YOUNGER COMPONENT OF HC

#### YOUTH IS A SCARCE RESOURCE IN ADRION

- DUE TO DEMOGRAPHIC TRENDS: DECLINING BIRTHS AND MOBILITY
- STRAINED PARTICIPATION AND PRODUCTIVITY LEVELS
- IN ORDER TO COMPENSATE FOR DECLINE, YOUTH PARTICIPATION RATES MUST BE AS HIGH AS POSSIBLE (AND PRODUCTIVE AND INNOVATIVE)

#### CLEAR NEED FOR A TRANSNATIONAL APPROACH

- TERRITORIAL PERFORMANCE IS INFLUENCED BY TRANSNATIONAL MOVEMENTS
- INTERNATIONALISATION OF PRODUCTIVE VALUE CHAINS
- INTENSIFYING MIGRATORY TRENDS
- RELEVANCE OF REINFORCING THE AREA'S IDENTITY
