







ANALYSIS OF THE SURVEY ON THE IMPACT OF CRUISE TOURISM IN THE EUSAIR AREA


1.ECONOMIC IMPACTS

From the analysis of the answers of the survey respondents appear clearly that cruise tourism has a major economic impact within the EUSAIR area. Referring to the job opportunities generated by this sector is shown that cruise tourism generates more seasonal jobs rather than permanent jobs contributing in this way to the increased income of residents.

The cruise tourism shows a positive impact also on the local economies, one-third of passengers are spending on traditional products and positive effects are shown also in terms of investment opportunities. The local start-ups are beneficiating of the support generated by the economies of this sector.

Less positive impacts are shown concerning the natural and built environment due to the new constructions.









2. ENVIRONMENTAL IMPACTS







3. SOCIAL AND INFRASTRUCTURAL IMPACTS

A high percentage of respondents states that due to the cruise tourism the number of cultural and entertainment events are increased and also this sector favors the restoration of archeological places and only 15% of the respondents consider that the cruise passengers have negatively affected their way of life.




4. EUSAIR DEVELOPMENT


More than a half of the repsondents consider that new destinations in the Eusair area should emerge and the future cruise development should focus on maritime economic activities other than cruise tourism and on increasing the economic benefits for locals. The majority of respondants also agreed on introducing incentives to passengers for visiting less congested places.

In conclusion, a better coordination and colaboration is needed among the respected governments at the AI macro-regional level, in order to control negative externalities of cruise tourism as well as for the sustainable development of EUSAIR destinations a permanent collaboration platform is considered useful.
